A medical assistant is a multi-skilled allied health care professional that specializes in procedures commonly performed in the ambulatory health care setting. Medical assistants perform both clinical and administrative duties and assist a variety of providers including physicians, nurse practitioners and physician assistants. They typically work in medical offices, clinics, urgent care centers and may work in general medicine or specialty practices. Common duties of a medical assistant include administrative and clinical tasks like:

- Checking patients in and out upon arrival and departure
- Answering phone calls and questions
- Assisting providers with exams and procedures
- Administering injections or medications
- Working in the electronic health record (EHR)
- Performing EKG, phlebotomy, and laboratory procedures
- Taking patient vital signs

Certified Logistics Program*

The purpose of the Certified Logistics Technician (CLT) program is to recognize through certification individuals who demonstrate mastery of the core competencies of material handling at the front-line (entry-level through front-line supervisor) through successful completion of the certification assessments. The goal of the CLT certification program is to raise the level of performance of logistics workers both to assist the individuals in finding higher-wage jobs and to help employers ensure their workforce increases the company's productivity and competitiveness. The CLT program consists of two parts: The foundational-level Certified Logistics Associate (CLA) Certificate and the mid-level technical CLT Certification. Before sitting for the CLT assessment, candidates must have a CLA Certificate.**

***MSSC strongly recommends that individuals be at an 8th-grade math and 10th-grade reading level before taking our Courses. Must be 18 years or older. No high school diploma or GED required.**

The Virginia Rider Training Program (VRTP) is DMV's motorcycle safety & licensing program recognized only by the state of Virginia. **Novice Rider Course – Participants must be physically able to balance and operate a motorcycle.**

The Virginia Rider Training program. Basic Rider Course (BRC) coaches the fundamental skills and is NOT intended to produce the superb riding skills of an experienced rider; rather, it provides the basic ENTRY-LEVEL skills for a new rider to begin practicing and developing the mental and motor skills important for safe street operation. **Motorcycle safety helmets and full riding gear, e.g. without limitation, long sleeve jacket or shirt, long pants, over the ankle boots or shoes, eye protection, ¾ or full-face helmet, and full-finger gloves, are used by all persons while mounting or seated on any MSLVI motorcycle.** Note that PDCCC provides the motorcycles and helmets for the course.

Workforce/LogistX Scholarship

Through the support and generosity of Hampton Roads LogistX Games and donations to PDCCC Workforce Development, scholarship provides up to \$250 toward students taking non-credit workforce-related certification courses. Eligibility Criteria: 18+ years of age, Virginia resident, and Copy of High School Diploma or GED.

GED & Adult Education Scholarship

The GED and Adult Education Scholarship was initially established as part of the Rural Virginia Horseshoe Initiative (RVHI), providing incentives for recent GED recipients to continue their education in the workforce and other programs of study in order to obtain gainful employment.

The GED & Adult Education Scholarship is available for students who meet the following criteria:

- Applicant must have earned either a GED certificate and be 18 years or over OR must have earned a High School Diploma and be 21 years or older.
- Applicant will need to provide a copy of their GED certificate / High School diploma or transcript.
- Applicant must be either low wage or low skill.
- Applicant must reside in the Western Tidewater communities of Franklin, Suffolk, Isle of Wight County, or Southampton County, Virginia
- Student will enroll into a Workforce non-credit certification course.
